**Do It 2022 Registration Policies and Fees**  
Adopted 7/13/2022

1. To participate in any WPA event, a person must be an active member of the WPA, or be the spouse, child, or sponsored guest of an active attending member.
2. Do It 2022 has registration categories and fees as detailed on page 1 of this registration form.
3. Spouse, partner, or children of Event Staff pay the fee shown on page 1.
4. Children 5 and under may attend with their parents for free.
5. Any current member that is registered for the event may have his or her spouse, whether the spouse is a member or not, attend the event at the reduced spouse rate.
6. A **\$50.00 clean up deposit** is included in the registration fee as noted in the above fee table. Any person registered for the event in any of the above categories, who signs in no later than 30 minutes after the announced clean-up start time, who ACTIVELY PARTICIPATES, and stays until cleanup is complete on Monday, will receive a share of the clean-up deposit as a refund. The amount will be calculated after clean-up expenses are determined. Children (less than 18) are ineligible to participate in clean-up for safety reasons.
7. A person who has never been a WPA member can attend a WPA event without a membership as a "Sponsored Guest", with the following conditions:
  - a. A person can do this ONCE in their lifetime.
  - b. They must be sponsored by an active member who is attending the event.
  - c. A member can only sponsor one Sponsored Guest per event.
  - d. They cannot preorder any product or buy "Class B" product.
  - e. They have no member number.
  - f. They cannot bring their spouse or other family members.
  - g. They may attend the annual meeting, but they cannot vote.
8. Camping in tents and RV's will be available on the racetrack site without charge. You must register for camping and indicate whether tent or RV. The location will be outside the racetrack proper. There will be walking access from manufacturing to the campsite and a port-a-potty will be convenient. You must agree to observe that no chemicals or manufactured items will be taken to or stored in your tent or RV. Also, be very much aware that this is total 'boon docking;' no electric, no water, no waste dump will be provided. Upon your arrival you will be directed where to park by the Event Chairman; please check in with him.
9. Any fraudulent use of event credentials, such as use of previous year's or someone else's, will result in disciplinary action against all involved persons, at the discretion of the WPA Board of Directors.

WAIVER OF LIABILITY AND ASSUMPTION OF RISK

The registrant, undersigned and individuals listed hereby agree to waive any and all liability resulting from any exposure to any communicable disease, potential exposure to any communicable disease, accidents, any negligence, any misuse, any type of participation either directly or indirectly with the seminars, activities, displays or fireworks or fireworks related activities, with respect to the owner of, or entity responsible for managing the land in which the fireworks are to be used, demonstrated, manufactured, sold, bought, displayed or destroyed, the Western Pyrotechnic Association, Inc., its members, officers, agents, employees, successors or licensees, any operator, any permit holder, any event vendor, or any instructor of or for fireworks use, public displays, demonstrations, competitions, sales or purchases of fireworks or fireworks related material or any other Pyrotechnic Event related activity. This waiver of liability goes to any intentional or negligent act that may be performed by the operator of a public display, owner of the land in which the fireworks are to be used, demonstrated, manufactured, sold, bought, displayed or destroyed, the Western Pyrotechnic Association, Inc., its members, officers, agents employees, successors or licensees, permit holder or instructor. All actions, participation and activities engaged in by the undersigned are voluntary.

The registrant, undersigned and individuals listed further agree to abide by all safety rules and personal conduct guidelines of the Western Pyrotechnic Association, Inc., fireworks laws and regulations of the state in which DO IT is held or regulations of any other authority with jurisdiction. It is expressly understood that any violation, deviation, failure to obey and follow said rules, guidelines, laws or regulations by the registrant or undersigned is cause for the immediate suspension of DO IT privileges, immediate revocation of membership in the Western Pyrotechnic Association, Inc. and immediate expulsion from the land, without any right to return, upon which said DO IT activities are being held.

The registrant, undersigned and individuals listed expressly state that they are the parent or guardian for any minor listed below and agrees that all terms of the foregoing Waiver of Liability applies to said minors.

The registrant, undersigned and individuals listed below understand that pyrotechnic material is and will be used at DO IT, that a risk is associated with the use of pyrotechnic material, even if the pyrotechnic material is handled in an appropriate manner and all applicable safety rules and guidelines are followed. The Registrant or undersigned understand the risk associated with pyrotechnic material and voluntarily assume said risk associated with the use of pyrotechnic material at DO IT.
